- 1.1 dunnhumby Products & Platforms are owned and operated by dunnhumby Limited ("dunnhumby", "we", "us" or "our").
- 1.2 Our Cookie Notice explains:
- how we use cookies and similar technologies ("cookies") to recognise you when you visit and use our Products & Platforms, listed in Annex 1; and
 - the cookies we use, why we use them and how you can control our use of cookies.
- 1.3 This Cookie Notice does not apply to:
- information about consumers who purchase products or services from dunnhumby clients. Any information provided to our clients through our Products & Platforms is provided in aggregate form only and does not identify individual consumers;

3. What are cookies?

Overview

- 3.1 Cookies are small text files which are placed and stored on your computer, mobile or other device when you first visit our Products & Platforms. We use cookies to help our Products & Platforms work effectively and efficiently.
- 3.2 We also use a technology similar to cookies called LocalStorage to provide you with 'tour' functionality and remember your selected language preference when using our Products & Platforms. LocalStorage is an industry standard technology that allows information to be stored locally on your computer, mobile device, or other device.
- 3.3 For the purposes of this notice, the term 'cookies' also refers to LocalStorage.

4. Types of cookies

4.1 Source of cookies

- **First party cookies** – cookies we set on our Products & Platforms.
- **Third party cookies** – cookies set by other companies (including, our group companies) on our Products & Platforms.

4.2 Categories of cookies

- **Strictly necessary cookies** – cookies that are essential for operation, and your use, of our Products & Platforms.
- **Functionality cookies** – cookies that help us to recognise you and improve the functionality of our Products & Platforms.
- **Analytical cookies** – cookies that collect information about your use of our Products & Platforms and monitor the performance of our Products & Platforms to help us improve performance; the services we provide to you through our Products & Platforms and your experience of using it.

4.3 Duration of cookies

- **Session cookies** – cookies that start working when you access our Products & Platforms and stop when you log-out.
- **Persistent cookies** – cookies that remain stored on your device for a defined period of time and are deleted automatically once they expire, or earlier if you delete them manually.

Where we are required to obtain your consent to store non-essential cookies on your device, we will request this consent. If you do not consent, we will not use those non-essential cookies in that jurisdiction.
